PRESIDENT'S REPORT

This year has been a year of adaptations. As we teach in grade 3 of the River-Lab Program, organisms adapt to maximize their success within their habitats. Our organization is no different. In 2018, Mill River Wetland Committee faced a number of changes and has begun to adapt in order to continue being the best local resource for environmental education.

The greatest change we face is the implementation of the Next Generation Science Standards within the science curriculum. While student led discovery and relevant scientific practice has been a cornerstone of the River-Lab Program, there are adjustments in alignment of the content areas in each grade level. Our Curriculum Committee, River-Lab Directors and Board have all been involved in restructuring our program. Last Spring, we implemented a new pilot program for grade 5 using our key concepts to better align with the new curriculum. In addition, the Estuary program did not run during the year to allow for better curriculum relevance with students who are in grade 7 this year.

Another exciting change that MRWC was involved with relates to our local community of Fairfield. Fairfield is taking a leadership role in the state with our town's new Sustainability Plan. MRWC is committed to being a community leader in environmental education to support the town's direction. This past year, we reached out to other like minded organizations and will continue to partner with others to further sustainability initiatives.

MRWC has always been an organization committed to educating our community about environmental issues, engaging them to make active choices to support sustainability and to advocate for the health of our watershed and greater environment. In the past year, we have found that we stand solidly behind that mission as we incorporate new and exciting methods of implementation.

HIGHLIGHTS

While 2018 was full of exciting developments, we are especially proud of the recognition MRWC received for our part of Fairfield's application to the Sustainable CT initiative. One of just 5 communities awarded Silver Certification, the highest possible designation, Fairfield earned the most points of any community for sustainability actions across 9 broad categories. We worked with the Sustainable Fairfield Task Force to demonstrate how our programs provide "Watershed Education" under the "Well-Stewarded Land and Natural Resources" category. Our River-Lab Program was specifically highlighted by the Sustainable CT Review Committee for the breadth and scope of our public education outreach efforts. The accolades for the River-Lab Program reinforced the important role of early environmental education in a long term sustainability solution.

BUILDING ON THE MOMENTUM OF 2017, MRWC CONTINUED TO INCREASE OUR COMMUNITY INVOLVEMENT OUTSIDE THE RIVER-LAB PROGRAM. WE FORGED NEW PARTNERSHIPS WITH:

- Wild Birds Unlimited on Black Rock Turnpike. Together, we ran a scavenger hunt for young students to learn about birds that spend winter in Connecticut and the challenges they face.
- Dr. Jennifer Mattei from the Biology Department at Sacred Heart University. At our Annual Meeting, she spoke about the significant progress made against coastal erosion with the artificial reefs installed at Stratford Point. In addition, we organized a group of volunteers to support her Earth Day initiative to plant estuary grasses to further combat erosion.
- Other CT environmental groups on projects large and small. The biggest joint project was an effort to spread the word about the Public Land Conveyance Protections included on the November 2018 ballot (Question 2). Almost 85% of voters approved the amendment to the CT Constitution requiring a public hearing before public lands can be sold, swapped, or given away by special acts in the General Assembly.
 A victory for all!

2018 HIGHLIGHTS

- The Board of Education for Fairfield Public Schools (FPS) officially approved a new science curriculum which continues to drive changes to the River-Lab Program.
- Dedicated curriculum committee volunteers developed and piloted a new study-trip for 5th grade. The pilot study-trips represent a fundamental shift to student-driven observations and question formation. This shift challenges students, teachers and parents (our guides) to hone their observation skills while resisting the tendency to make assumptions and give information, even unconsciously!
- Four schools (Assumption, McKinley, Riverfield, and St. Thomas) piloted the new study-trip. These pilot trips were led by our curriculum committee volunteers. The regular 5th grade study-trips ran concurrently for all 9 remaining elementary schools.
- The Estuary study-trip, the final unit in our River-Lab Program, did not run in 2018 due to the FPS' new science curriculum shift (river basin systems are now taught in 7th grade). Therefore, those students will visit the estuary in Spring 2019, ensuring all students have the opportunity to observe the river basin system's link to the Long Island Sound.
- The parochial school 6th grade curriculum continues to study the estuary in grade 6. Those students visited the estuary in the fall of 2017.
- The grade level mismatch between FPS and the parochial schools precipitated the name change to the River-Lab Estuary study-trip, focusing on the program content rather than grade level.
- Study-trips for grades 3 and 4 ran in the Fall according to plan. We anticipate changes to the study-trips in 2019 as a result of continued grade level shifts in the science curriculum concepts within FPS.

CURRICULUM NEWS

Curriculum development continues to be a priority as we adjust the River-Lab Program to align with the grade level expectations of the Next Generation Science Standards (NGSS) and the updated science curriculum adopted by Fairfield Public Schools (FPS). The Curriculum Committee piloted a new grade 5 study trip which focuses on how organisms of the floodplain interact with one another, transfer energy, and influence the ecosystem. In the NGSS, students are encouraged to observe closely, gather data, and develop their own questions about these patterns of interactions. The pilot was a huge success and will run again this spring.

In July, members of the Curriculum Committee collaborated with FPS teachers and administrators to outline the ways in which River-Lab study trips support the newly adopted science curriculum in the remaining elementary grades. As a result of that work, Curriculum Committee members will spend 2019 creating NGSS-aligned field experiences for grade 4 that highlight the effects of weathering and erosion. In addition, the team will develop new guide training that prepares guides for the significant shift to the NGSS focus on student observations, data gathering and question formation.

The River-Lab Estuary program, formerly taught in grade 6, will be presented in grade 7 where it aligns with the content in the "Ecosystems" unit. On the study trip, students observe and record conditions, perform field tests of water quality, and assess the biodiversity of the estuary. Data gathered in the field is collected and analyzed in order to find patterns and prompt scientific inquiries about the health of the estuary and the entire river basin system.

Although the grade specific content and pedagogical practices are changing, Fairfield educators remain committed to using our local river basin to engage students in science learning. River-Lab remains a valued resource to educate Fairfield's next generation of environmentally aware citizens.
